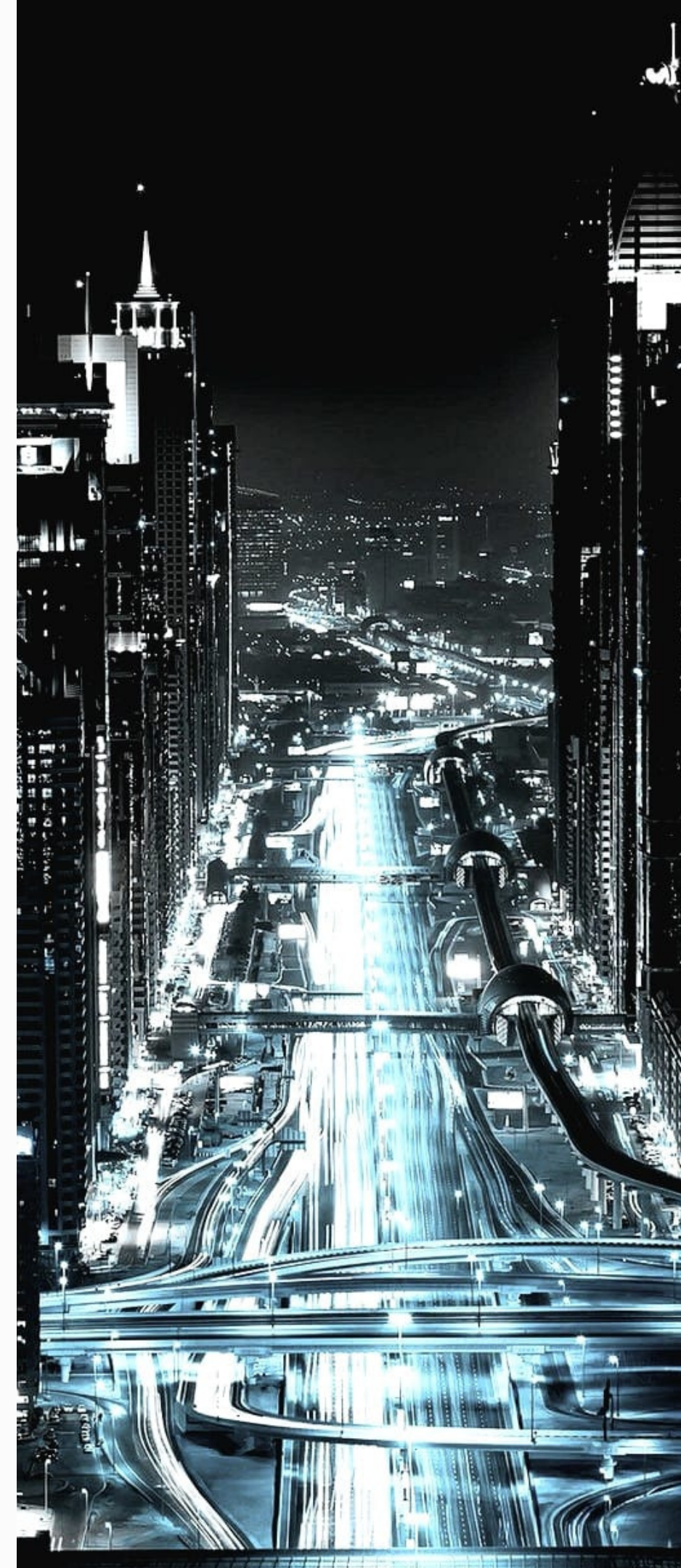

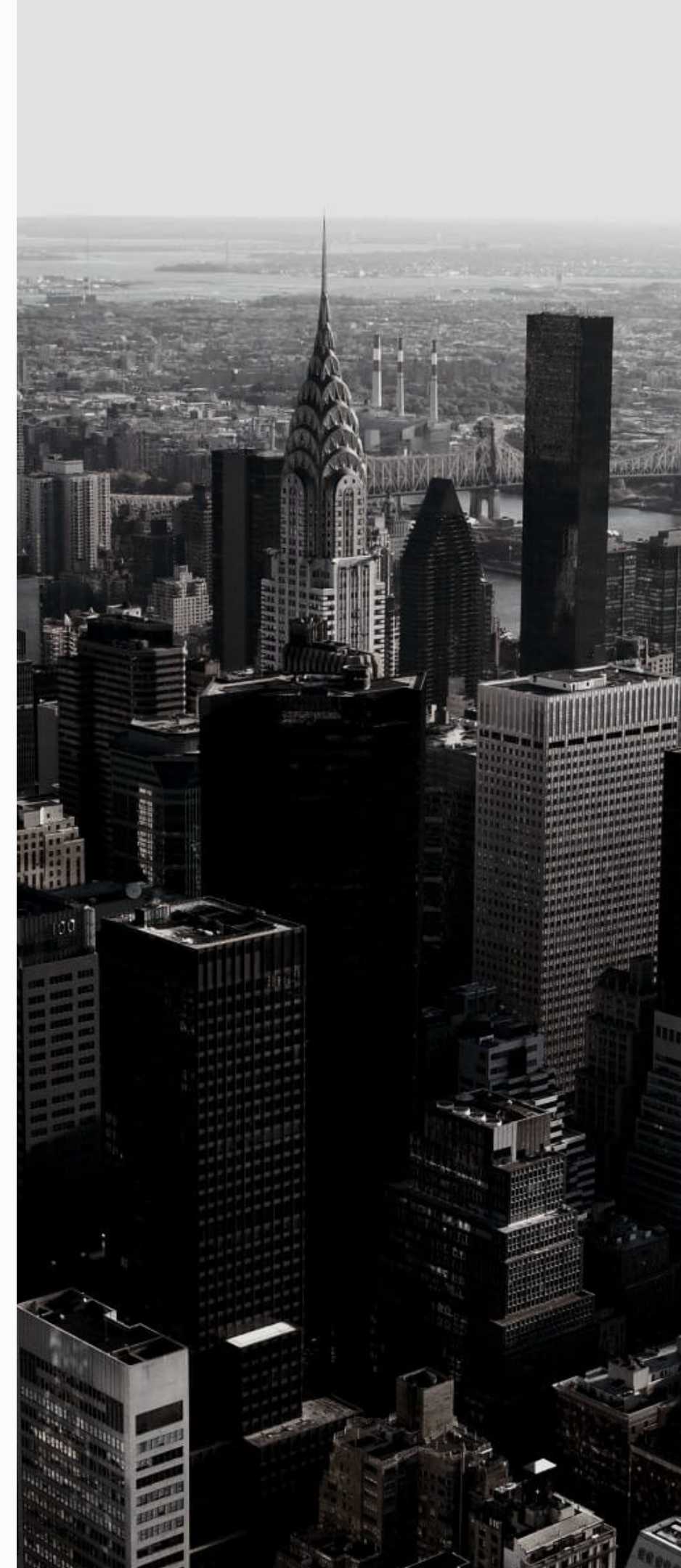

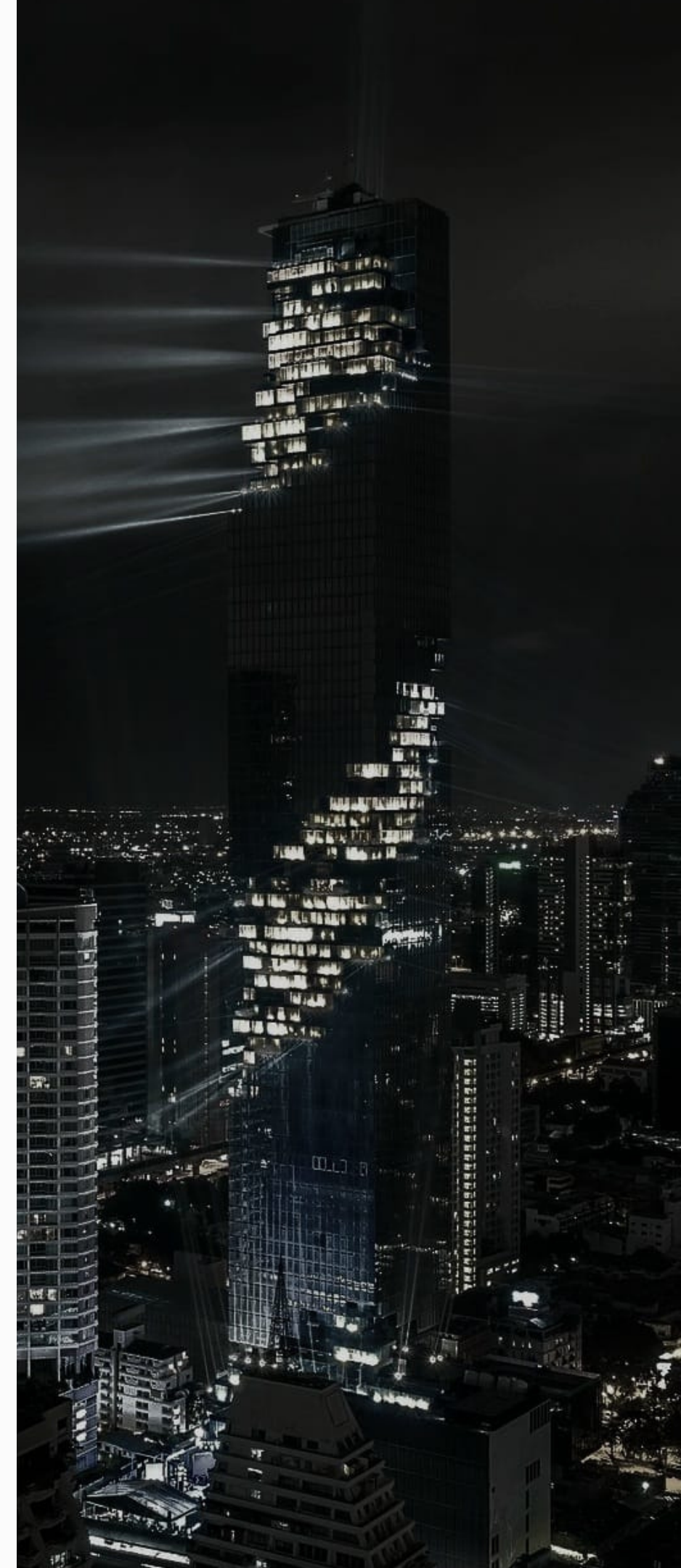




Tri Cahyo Wibowo, S.H., M.H.

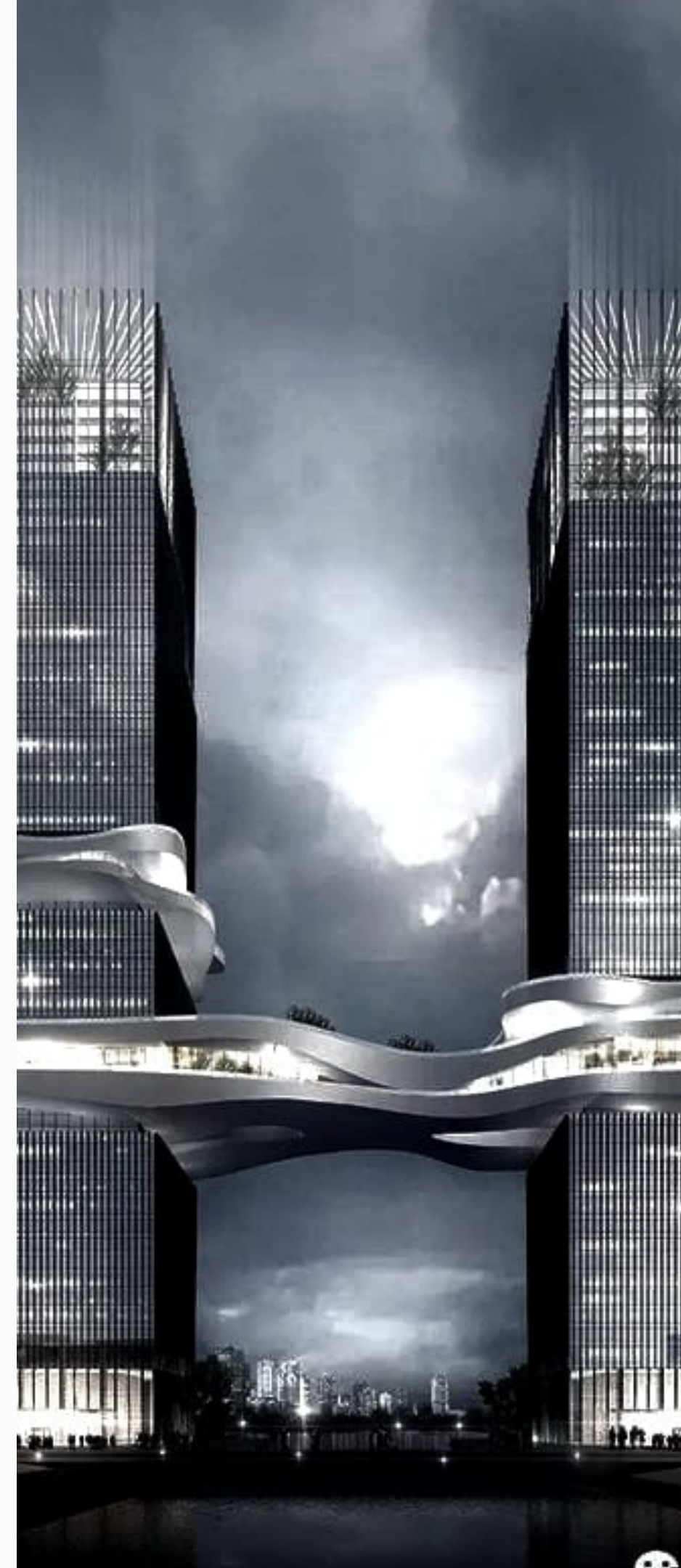
